

- 1). Lead Investigative Services, Inc. (LISI) has received many small contracts from the St. Paul Public Housing Agency. The contracts averaged \$2,500.00 per contract and totalled \$29,160.00. This work was performed between 10-26-11 and 5-5-13.
- 2). LISI has received a contract to perform lead services at 1901 EM Statey Avenue, Minnaapolls MN in the amount of \$4,000.00. The contract used HUD funds and Ice Box Construction was the general contractor. This project was performed in 2011.
- 3). LISI was contracted to perform lead services for a private owner of the property located at 2527 Washington Avenue NE, Minneapolis, MN in the amount of \$6,750.00 (estimated). The project used HUD funds. This project was performed in 2012.
- 4). LISI was contracted to perform lead services for a private owner of the property at 2795 Columbus Avenue, Minneapolis in the amount of \$7,650.00 (estimated). This work was completed in 2011.
- 5). LISI was contracted to perform lead services at the Stradford Flats project located at 15 16<sup>th</sup> Street, Minneapolis, MN for a general contractor, namely Watson Forsberg Company. The project had HUD funds and the amount of the contract was \$1,253.33. The work was performed in March 2013.
- 6). Nails Construction Company has received many small contracts from the St. Paul Public Housing Agency. The contracts averaged \$3,000.00 per contract and totalled \$14,285.00. The work was performed between 10-27-11 and 5-5-13.

The grant was for community engagement regarding Section 3 and was awarded in 2012.
